

Linnsmore Crescent and Strathmore Boulevard Restored for Vehicular/Pedestrian Traffic

Easier Access Program

Timeline:

Stage 5 of construction starting as early as July 28

*Content/timeline accurate at the time of printing. Pending weather, unforeseen site conditions and events.

What we are doing and why:

TTC is working to make Greenwood Station accessible with two new elevators - scheduled to open in mid-2025.*

Construction will progress to stage 5 as early as July 28*. The intersection of Linnsmore Crescent and Strathmore Boulevard will be restored for vehicular/pedestrian traffic. Construction continues underground, on street level around the station building, and within the station. Crews will be restoring the City ROW by backfilling the soil and compacting the new roadway and sidewalks. Odours and vibration from compaction rollers can be expected. This helps the soil settle into place during compaction. Following restoration landscaping will be completed (date TBD).

The overall project will be conducted in various stages. Updates will be posted here: <u>Greenwood Station</u> (<u>ttc.ca</u>)

Construction stage 5:



- Intersection of Linnsmore Crescent and Strathmore Boulevard restored to vehicular/pedestrian traffic.
- Construction trucks, equipment and site staff will be present in the general area.
- Pedestrian detours will be in place.
- Lane configurations may shift as work progresses.
- No impacts to subway service on Line 2 Bloor Danforth.

Noise, vibration, and work hours

Noise, dust and vibration associated with construction can be expected with this work. Efforts will be made to keep levels to a minimum.
