Greenwood Station Easier Access Project

Temporary station entrance/exit diversion to accommodate works for the re-opening of the sidewalk and progress to stage 6 of construction

Timeline:

Temporary diversion of station entrance/exit starting as early as December 21 up to December 24, 2024*

Sidewalk to re-open as early as December 31, 2024* (Stage 6 of construction)

* Content/timeline accurate at the time of printing. Pending weather, possible third-party union strikes, and unforeseen site conditions and events.

What we are doing and why:


TTC is working to make Greenwood Station accessible with two new elevators - scheduled to be in-service in mid-2025*

Construction will progress to stage 6 as early as December 31, 2024*. In order to accommodate new pavement and the re-opening of the sidewalk in front of the station entrance, the contractor has to temporarily divert the entrance/exit to the station from December 21 – 24, 2024. **Customers will temporarily enter/exit the station from the bus loop through side doors on the station's south side.** Customer detour signage will be in place. Customer service representatives will be present at the station to assist customers during the minor diversion. There will be *no* disruption to subway service at Greenwood Station for this work. Protective barriers will be provided at the main entrance/exit to facilitate this work. For safety reasons, some work and the initial set-up and removal of the access area will occur overnight through the entrance doors at the station.

*Pending weather, third-party union strikes, and unforeseen site conditions and events.

The overall project is being conducted in stages. Updates will be posted here: (<u>Greenwood Station Easier Access Elevator project</u>)

Construction stage 6:



- Construction continues underground, on street level, around the station building, and within the station
- Sidewalk at Linnsmore Crescent and Strathmore Boulevard restored to pedestrian traffic.
- Construction trucks, equipment, and site staff will be present in the general area.
- No impacts to subway service on Line 2 Bloor Danforth.
