# SENIOR MANAGEMENT ANNUAL REVIEW OF THE ENVIRONMENT, HEALTH & SAFETY (EHS) MANAGEMENT SYSTEM TUESDAY, MARCH 29, 2011 2:30 PM

A Senior Management Annual Review of the EHS Management System was held in the 7<sup>th</sup> floor Boardroom, on Tuesday, March 29, 2011 commencing at 2:30 PM.

Present were Gary Webster, Vincent Rodo, John Sepulis, Dave Dixon, Jim Teeple, Bill Frost, John O'Grady, Brian Leck, Joanne DiBiase, Mike Roche, Sandra Sutherland, Andrew McKinnon, Candace Freyseng and Mary Zigomanis.

# 1. Legal Developments

Brian Leck provided an overview of the safety and environmental legal responsibilities associated with the Occupational Health and Safety Act and Bill C-45 Amendments to the Criminal Code, and the obligations of senior management and its directors and officers.

It was agreed to include background and history involving serious safety incidents which led to implementing the safety culture initiative.

# 2. EHS Management System

John O'Grady reviewed the 2010 performance in Occupational Health and Safety, Customer and Public Safety, and Environment by presenting highlights from analysis of TTC performance indicators, trends in assessment results, and regulatory oversight (upcoming legislation and compliance). He provided updates to various EHS initiatives some of which include the Work Safe-Home Safe initiative, Joint Health and Safety Committee Day, and platform distress phones. John then presented the 2011 Action Plan which was set to improve the management system and will be monitored at quarterly Safety System Review meetings.
