## BACKGROUND

At its meeting on February 9, 2005, the Commission commenced a review process of the TTC's Corporate Policy Manual.

#### DISCUSSION

The Corporate Policy & Instruction 10.14.5 - *Safety, Health, and Environment* for 2012 was approved in principle by the Chief General Manager at the June 29, 2011 Safety System Review Meeting.

The Corporate Policy & Instruction 10.14.5 - *Safety, Health, and Environment* for 2012 integrates the TTC's commitments to safety and the environment currently established within two separate Policies & Instructions, 10.14 – *Safety* and 10.12 – *Environment*, into one Policy & Instruction – 10.14 *Safety, Health, and Environment*.

The Corporate Policy & Instruction 10.14 is reviewed on an annual basis as required by the Ontario *Occupational Health and Safety Act*. The policy for 2012 is being sent now to the Commission for approval in order to release the updated policy in January 2012.



## 2.0 PURPOSE

The Toronto Transit Commission commits to reduce the environmental impacts from our facility and vehicle operations and comply with all legal and applicable requirements.

#### 3.0 <u>GENERAL</u>

To achieve this policy the Toronto Transit Commission will:

- 3.1 Develop and operate our environmental management system to a standard equivalent to the requirements of ISO 14001.
- 3.2 Comply with all environmental statutes, regulations and local by-laws.
- 3.3 Establish specific environmental performance goals through the budget process and report on achievement.
- 3.4 Integrate environmental protection consideration into future planning and decisions.
- 3.5 Ensure proper handling and disposition of wastes and employ source reduction and other pollution prevention approaches whenever practicable.
- 3.6 Train all staff to make them aware of the TTC environmental policy objectives and targets appropriate to their roles.
- 3.7 Implement quality program to ensure environmental compliance.
- 3.8 Conduct regular reviews of the environmental management system, targets, objectives and policy to ensure its currency.
- 3.9 Commit to continual development and improvement of the environmental management system.
