TTC staff are in regular communication with the Advisory Committee on Accessible Transit (ACAT) Communications Subcommittee on means to enhance accessibility to meetings.

The 2022 meeting schedule avoids meetings on days of cultural or religious significance.

Decision History

The TTC Bylaw to Govern Board Proceedings Section 20, Regular meetings; annual schedule requires the Director – Commission Services to recommend an annual schedule of Board and Committee meetings to the Board each year.

City Council, at its meeting on November 9 and 10, 2021 approved Item ST9.2 – 2022 Schedule of Meetings. The proposed 2022 TTC meeting dates have been prepared in consideration of the foregoing and in recognition of City Council's direction that City agencies avoid scheduling meetings, wherever possible, that conflict with the approved City meeting schedule and respecting days of cultural or religious significance.

Comments

2022 is a Municipal Election year

The Municipal Election will take place on Monday, October 24, 2022. Traditionally, the TTC Board has followed the approach taken by the City of Toronto and not scheduled any Board meetings after Nomination Day, which is August 19, 2022.

The TTC Chair may call a Special meeting, if required, to deal with any urgent items.

Proposed Meeting Schedule

The approved City meeting schedule preserved days for the City's agency boards and special committees to hold meetings. TTC Board meetings have been scheduled on the dates set aside for agencies, where possible, in order to avoid any potential conflicts with the City schedule and to facilitate the transmittal of key items to the City's Executive Committee. In keeping with the City's scheduling practice, no meeting of the Board has been scheduled in March to allow for a winter break.

There are two recommended meeting dates for the Audit & Risk Management Committee during the months of March and June. This schedule takes into consideration anticipated timing of items such as annual financial and external auditor reporting.

Meetings of the TTC's two subsidiary companies, the Toronto Transit Commission Insurance Company Limited and the Toronto Coach Terminal Incorporated, are scheduled in advance of the February and June Board meetings. These meetings are noted on the 2022 Schedule of Meetings (calendar view), included as Attachment 1 to this report.

Regular TTC Board meetings will begin at 10 a.m. Audit & Risk Management Committee meetings will begin at 8:30 a.m.

Electronic Meetings

The TTC Board has extended its electronic participation rules for one year following the later of the termination of the Provincial emergency or the termination of the municipal emergency. As a result, it is anticipated that electronic participation in meetings will continue in 2022. TTC staff continue to monitor advancements in technology and electronic meeting management processes in other jurisdictions in order to provide seamless, user-friendly and accessible meetings and to determine whether any enhancements should be implemented.
