

Toronto-York Spadina Subway Extension – Litigation Status Update

Reason for Confidential Information

This report is about litigation or potential litigation, including matters before administrative tribunals.

Summary

On June 20, 2011, Bondfield was awarded the contract for Toronto-York Spadina Subway Extension Finch West Station, Contract A27-1 in the amount of \$125.63 million. The final approved value is approximately \$154.387 million (inclusive of HST).

On September 22, 2011, Walsh was awarded the contract for the Steeles West Station, (renamed to Pioneer Village Station), Contract A31-1 in the amount of \$165.925 million. The final approved value of the Contract is approximately \$223.207 million (inclusive of HST).

This report includes recommendations and requests the Board's approval of funds to provide resolution related Finch West Station and to increase the upset limit of the TYSSE project controls contract to support ongoing claims. This report also includes an update on the litigation related to Steeles West Station.

Recommendations

It is recommended that the Board:

- 1. Approve a contract amendment to Contract A85-70 Project Control Services, increasing the upset limit amount by \$400,000.00 (including taxes), bringing the total upset limit amount to \$63.235 million (including taxes) and extending the contract expiry from March 31, 2022 to December 31, 2022.
- 2. Approve the recommendation outlined in the confidential attachment; and
- 3. Authorize the information contained in the confidential attachment to remain confidential as it contains advice that is subject to solicitor-client privilege and is

about litigation or potential litigation, including matters before administrative tribunals.

Financial Summary

Funds for this expenditure are included in the TTC's 2022 – 2031 Capital Budget and Plan under the Toronto - York Spadina Subway Extension (TYSSE) Project which was approved by the TTC Board at its meeting on December 20, 2021 and will be before City Council for consideration on February 17, 2022. The total TYSSE Project cost is \$3.184 billion.

Additional financial information is included in the Confidential Attachment.

The Chief Financial Officer has reviewed this report and agrees with the financial impact information.

Equity/Accessibility Matters

A cornerstone of the TTC's Corporate Plan 2018 - 2022 is accessibility, and as a proud leader in providing accessible public transit in the city of Toronto, we are committed to ensuring reliable, safe and inclusive transit services for all our customers. This is supported through the TYSSE project which went into service at the end of 2017. The TYSSE project connected the City of Toronto and York Region, which allowed for greater mobility and connectivity across regions for riders.

Ensuring barrier-free access is a priority and all TYSSE stations have extensive facilities (including elevators, escalators, tactile markings, etc.) that are in compliance with the *Accessibility for Ontarians with Disabilities Act*, 2005 (AODA). Further, the service that the TYSSE provides improves access to jobs, education, and other opportunities, for a large number of residents of Toronto and York Region, including students at York University.

Decision History

On October 23, 2008, the Board approved awarding contracts for the design of Steeles West Station (renamed Pioneer Village Station) and Finch West Station as part of the TYSSE Project to The Spadina Group Associates.

On May 11, 2011, the Board approved awarding Bondfield Construction Company Limited (Bondfield) the contract for the Toronto-York Spadina Subway Extension Finch West Station, Contract A27-1, in the amount of \$125.63 million.

Issue Background

On March 12, 2008, Contract A85-70 Project Control Services was awarded to Stantec Consulting Ltd. The scope of work for the contract was to provide project controls services for the TYSSE.

As part of the TYSSE Project, on October 24, 2008, the TTC awarded design contracts for both Finch West Station and Steeles West Station to a joint venture known as The Spadina Group Associates (Contracts A85-75A and A85-75B).

During the execution of the work as part of Contract A27-1, delays were encountered in the construction of the station resulting in claims from Bondfield. This report provides recommendations for the full and final resolution of all claims related to the design and construction of Finch West Station.

During the execution of the work as part of Contract A31-1, delays were encountered in the construction of the station resulting in claims from Walsh. This report provides an update of the status of the litigation related to the design and construction of Steeles West Station.

Comments

The confidential attachment to this report provides advice, subject to both solicitor-client privilege and litigation privilege, relating to potential resolution of claims relating to the design and construction of Finch West Station and the ongoing litigation relating to the design and construction of Steeles West Station.

On March 12, 2008, Contract A85-70 Project Control Services was awarded to Stantec Consulting Ltd. To date, there have been 17 contract amendments which are summarized in Schedule A.

The TYSSE project is currently focused on resolving commercial claims and property claims along with ongoing reporting required to the Executive Task Force (ETF). In addition to the two station contractor claims described herein, there are eight property/business loss claims that remain outstanding. Accordingly, project control services contract A85-70 requires an amendment to continue to provide the required services including:

- Performing various accounting function, including budgeting, cost control analysis and reporting, including reporting to the ETF; and
- Supporting property claims and commercial claims with historical information, preparation of affidavits and pre-trail reports and providing witnesses for the trial;
