Summary

The purpose of this report is to seek approval for the appointment of the external auditor for the 2015 fiscal year. Audit services are required to complete the annual financial audit pursuant to Section 102 of the Insurance Act (Ontario).

Recommendations

It is recommended that the shareholders

1. Approve the appointment of PricewaterhouseCoopers LLP for the provision of external audit services for the 2015 fiscal year.

Financial Summary

Sufficient funds are included in the TTC's 2015 operating budget, as approved by the Board on February 2, 2015 and approved by City of Toronto Council on March 10/11, 2015. Sufficient funds will be included in future years' operating budgets as appropriate.

The Chief Financial & Administration Officer has reviewed this report and agrees with the financial impact information.

Decision History

On March 31, 2015, City Council authorized the Auditor General to enter into an agreement with PricewaterhouseCoopers LLP (PWC) to perform the annual financial statement audits for the years 2015 to 2019 inclusive for the City of Toronto and certain of its agencies and corporations, including TTC Insurance Company Limited, on the terms and conditions set out in the RFP and in a form satisfactory to the City Solicitor.
