Summary

At the first meeting of the Board after the election of Directors, the Board appoints a President, a Vice-President, a General Secretary and if deemed advisable, may appoint a Treasurer, a Comptroller, a General Counsel and such other officers as the Board may determine. None of the said officers need be a Director or shareholder. Any two of the said offices may be held by the same person.

Recommendations

It is recommended that the Board of Directors appoint:

- 1. Vincent Rodo, TTC Chief Financial and Administration Officer, to the position of President and General Secretary,
- 2. Brian Leck, TTC Head of Legal and General Counsel, to the position of Vice-President and General Counsel, and
- 3. Paul F. Buttigieg, TTC Director Budgets, Costing and Financial Reporting, to the position of Treasurer.

Decision History

At the TCTI General Meeting on June 22, 2015, the Board of Directors appointed Vincent Rodo as President and General Secretary, Brian Leck as Vice-President and General Counsel and Paul F. Buttigieg as Treasurer.

The Comptroller, who would act as assistant to the Treasurer, was not deemed required based on the limited financial activity of the Corporation.

The position of Director - Terminal Operations was on record prior to the 2013 Annual General meeting but was eliminated as the operation and management of the terminal had been leased out to a consortium of carriers.

Issue Background

Outlined below are the duties of the Officers as laid out in the TCTI By-law; noting that the Board may vary, add to or limit the powers and duties of any Officer or Officers of the Corporation.

The President is charged with the general management and direction, subject to the authority of the Board, of the Corporation's business and affairs and the power to appoint and remove any and all officers, employees and agents of the Corporation not elected or appointed directly by the Board and to settle the terms of their employment and remuneration.

The Vice-President will perform all the duties of the President in their absence and will also perform such duties as the President may from time to time delegate to the Vice-President.

The General Secretary is responsible for issuing all notices for all meetings of the Board of Directors, or shareholders, having charge of the minute books of the Corporation, keeping all issued share certificates in the custody of the General Secretary; signing with the Chair or other signing officers of the Corporation such instruments as require the General Secretary's signature, and performing such other duties as the Board of Directors may from time to time properly require of the General Secretary. The General Secretary will keep a record of:

- (a) A copy of the letters patent incorporating the Corporation and of any supplementary letters patent and of the preliminary memorandum of agreement, and all the by-laws if the Corporation; and
- (b) The names of all persons who are or have been shareholders.

The Treasurer is responsible for keeping proper accounting records as required by the Act; the Treasurer deposits all monies received by the Corporation in the Corporation's bank account; and under the direction of the Board, supervises the safekeeping of securities and the disbursement of the funds of the Corporation. The Treasurer renders to the Board, whenever required, an account of all transactions rendered as treasurer and of the financial position of the Corporation; and will perform such other duties as may from time to time be prescribed by the Board.

The General Counsel is responsible for all legal matters pertaining to the business of the Corporation and to fulfill such other duties as the Board of Directors may from time to time properly require of the General Counsel.

Comments

In accordance with the Ontario Corporations Information Act, the name and address of Officers of the Corporation must be filed with the Ministry of Government Services. This requirement will be fulfilled by the General Secretary upon appointment of Officers.
